## **Up Front with Gary**

Welcome to an update on activities at your Society. Rather than just have two newsletters a year and based on member feedback, we've introduced this shorter interim update, the Hi Society Bulletin.

The rise and further rise of base rates has come as a welcome relief for our savers who suffered for many years when base rates were stuck at or below 0.5%. The Society has responded to all fourteen changes up to the end of August 2023. This has kept the teams really busy with creating new products or adjusting rates for existing savings accounts so our members can benefit from better returns.

For mortgage customers the news of increasing base rates isn't so welcome. After what had been a protracted period of low mortgage rates they're now somewhere near to the long-term average before the crash of 2008. Ongoing high inflation continues to drive the Bank of England's decision-making processes when considering base rate changes. The Society is conscious of the impact on borrowers of changing our mortgage reference rate which is why we've increased that less often and by a much smaller amount in total since the Bank of England started moving rates in December 2021.

Some of you will have read about the Mortgage Charter announced in June this year. As the practices and commitments to the customer were already aligned with how we work it was easy for us to sign up to it and we did so on the same weekend it was communicated to lenders by the Treasury via our trade association.

Lending in the year has been strong despite the interest rate challenges I mentioned earlier and we're already above our previous annual record for gross lending with two months to go. When we post our annual results Members will see that the Society has grown again this year having broken through the £0.5 billion mark in total assets earlier in the summer.

The new IT systems which will launch next year will allow members greater access to their accounts. We will seek input from our members panel as part of our testing process. If you would like to join our member panel, please contact us at lbsmembers@theloughborough.co.uk

On other matters, work has started on refurbishing our new head office building in Loughborough. We've received all our planning consents for things like solar panels on the roof, as we are building in more energy efficient and environmentally friendly systems.
